## HOW TO REQUEST ACCESS TO RECORDS HELD BY KOELFONTEIN (PTY) LTD

Requests for access to records held by *Koelfontein (Pty) Ltd* must be made on the request forms that are available from our offices, or from the *SAHRC* website (<u>www.sahrc.org.za</u>)

When a record is requested, the following will apply:

- Fees may be payable. These fees are prescribed by law, and can change from time to time. The fee list is attached to this document.
- The Request Form must be completed. It can be obtained from the Information Officer, on the SAHRC website of the Department of Justice (www.justice.gov.za) under "PAIA" and "forms".
- On the Request Form all detail must be completed, including the right the requester wants to protect by requesting the information.
- If the Requester is acting on behalf of someone else (eg. an attorney acting on behalf of a client), the signature of the other person as the one who authorized the request to be made, has to be on the form and we have the right to check with the client that he/she indeed authorized such request.
- The Requester must state in which form (inspection of copy, electronic copy, transcript, etc.) he/she wants to access the information.
- If the record is part of another record, the Requester will only be able to access the part(s) that pertains to the information he/she wants or is entitled to, and not the rest of the record.
